

## CHURCH COUNCIL MEETING MINUTES

## ST. PAUL LUTHERAN CHURCH

June 8, 2021

1) **CALL TO ORDER** The meeting of the Church Council of St. Paul Lutheran Church was called to order by Clem Waskow. Council members present for the meeting were Pastor Tim Muehlbrad, Clem Waskow, Linda Peyton, Linda Hurta, Calvin Bruns, Michael Melanson, Hope Jendrzey, Jay Heil, Cindy Parma, and Cathy Moritz. Katie Serrano, Nicholas Requejo, Bill Klaevemann, Lori Kneese, and Johanna Warwas were also in attendance.

- 2) **DEVOTION** The devotion was given by Linda Peyton.
- 3) **MINUTES** The Minutes from May 11, 2021, were approved as printed with no corrections.
- 4) **REPORTS** 
  - a) Treasurer The balance in the General Fund as of May 31, 2021, was \$278,047.27. The balance in the Building Fund was \$10,863.15. Calvin Burns made a motion to accept the Treasurer's Report as printed. Cindy Parma seconded the motion. The motion carried.
  - b) Stewardship Nothing to report.
  - c) **Parish Education** Linda Hurta reported: She met with Linda Peyton and Nicholas Requejo to plan for Rally Day which is scheduled for August 29, 2021.
  - d) Youth Linda Peyton reported: The Summer Schedule Events are set. Six community events and one family event are planned. Nicholas Requejo will be assisting with Vacation Bible School. The youth assembled 125 hygiene kits for Project H.
  - Family/Youth Director Nicholas Requejo reported:
    Project H is completed. He delivered 125 hygiene kits to
    Mid-Coast Family Services. They were very appreciative.
  - f) Worship Jay Heil reported: Acolyte Training will be held on June 27, 2021, during the Sunday School hour. Pastor Tim will be taking a continuing education week from August 3-8, 2021. Pastor CB Suggs will be asked to conduct the church services that week.
  - g) Evangelism/Outreach No report.
  - h) Social Concerns Cindy Parma reported: One family requested, and received, assistance with an electric bill in May 2021.
  - i) Christian Life No report.

- j) **Property –** Michael Melanson reported the following:
  - 1. Bill Klaevemann fixed the door handle to the infant room at the day care.
  - 2. Bill Klaevemann fixed the kitchen sink in the fellowship hall.
  - 3. Electricians replaced outdoor lights around buildings.
  - 4. Fixed the toilet handle in the ladies' restroom in the educational building.
  - 5. Fixed the doors in the basement.
  - 6. Yearly maintenance on the bells was conducted.
  - 7. Replaced toy steering wheels on the playground.
  - 8. Sold lawnmower through a sealed bid for \$2,001.00.
  - 9. Purchased new lawnmower for the church grounds.
  - 10. Fixed the hinges on the playground gate.
- k) Cemetery No report.
- I) CEM Written report was provided.
- m) Pastor Professional activities during May 2021 included: 10 worship services, 1 hospital visit, 3 home visits, 7 educational events, and 5 church meetings and events. In addition, Pastor attended a 3-day NALC Pastor's Conference in San Antonio. He also officiated at the burial of Alvin Stanchos, Jr.

## 5) OLD BUSINESS

- a) Stained Glass Window Repair Bill Klaevemann reported: A&A Constructors should be through with the masonry work of the window project by next week and \$22,530.00 will be due. A payment of \$67,722.00 will be made when Foster Glass reinstalls the balcony window. When the protective coverings are installed, \$71,486.00 will be due. Once the painting is completed, Foster Glass will be paid \$16,000.00 to pay the painters. Suggestion was made to paint the benches around the big oak tree the same dark burgundy color as the base. This painting can be done after everything is completed.
- b) Announcements will be made regarding the financing of this project to avoid draining the LPL investment account.

This account also covers additional emergency expenses that arise.

## 6) NEW BUSINESS

- a) **Fire Alarm** Lori Kneese and Johanna Warwas reported: Bids have been obtained for the fire alarms, smoke detectors, and carbon monoxide detectors in the educational building and fellowship hall. In addition, the church will need to contract with an electrician for this project. The following bids were obtained:
  - a. H&H Door Company \$33,090.00 with an \$860.00 yearly monitoring fee.
  - b. Triple D Security \$16,388.00 with an \$840.00 yearly monitoring fee.
  - c. VCS \$26,996.00 with a \$540.00 yearly monitoring fee.
  - d. A-1 Shiner Fire & Safety \$21,595.00 with no monitoring fee amount provided.

After discussion, a motion was made by Jay Heil to accept the bid by Triple D Security who also manages the church alarm system. Linda Peyton seconded the motion. The motion carried.

- b) Payment for Fire Alarm A donation of \$10,000.00 has been made to CEM for the fire alarm system. Jay Heil made the motion to accept the \$10,000.00 from CEM and the church will pay the balance, monthly fees, and the cost of the electrician. Michael Melanson seconded the motion. The motion carried.
- c) Additional Delegate Pastor Tim received an e-mail today from the NALC advising that the church can send an additional delegate to the NALC Convention in Corpus Christi. A call for an additional delegate will be announced verbally and in the bulletin.
- CLOSING Jay Heil made the motion to adjourn the meeting. Linda Peyton seconded the motion. The motion carried, and the meeting closed with the Lord's Prayer.







As it does this year, July 4 fell on Sunday in 1937. While Pastor Eldred Johnston led worship that morning in Paulding, Ohio, local kids set off firecrackers nearby (restrictions were rare back then). Realizing he needed to act, the pastor slipped outside during a hymn and found the revelers.

But instead of scolding or shouting, Johnston stayed calm. "I used to enjoy shooting fireworks too," he said, adding that he knew it was a fun way to celebrate. "But many in this town are gathered in worship, and the noise is very distracting. All I'm asking is that you wait until church services are over — about noon — and then shoot firecrackers all you want." The pastor smiled at each youth and returned to church.



Recounting that experience in *Liberty* magazine, Johnston said he half-expected to hear defiant explosions. Instead, the kids waited respectfully until worship was over. When conflicts loom, may we heed that example — and this advice from Proverbs: "A gentle answer turns away wrath, but a harsh word stirs up anger" (15:1, NIV).

We now are faced with new challenges as we must pay the remaining amount of 140,000.00 due within 2 years from the date of purchase at 6% interest on a ten amortization schedule on a monthly basis plus attempting to build a structure for worship purposes. We feel confident that with god's grace we can succeed with this very ambitious program committed to the discipleship for the sake of Jesus Christ. Our motto is "not finished, just begun in 2021".
